



NOTĂ DE INFORMARE – GDPR

[EU General Data Protection Regulation]

The company **MEDEXPERT SRL**, with its head office in Turda str. Libertatii nr. 3 and place of business at no. 124A in Cluj-Napoca, Str. Câmpului, Cluj County, duly represented by Mr. Kőrösfőy László brings to your attention the following:

1. We comply with the legal provisions regarding the protection of personal data and enforce technical and organizational measures to protect all operations related, whether directly or indirectly, to personal data, which prevent unauthorized or illegal processing, as well as any accidental or illegal loss or destruction.

2. We process **your first and last name, home address and personal numeric code, e-mail address and telephone number, if applicable, for the following purposes:**

–to perform medical tests requested by you (occupational medicine examination, functional explorations and investigations, electrocardiogram, colour Doppler ultrasound, audiometry, ventilatory functional tests and others; investigations and functional tests; collection of medical laboratory tests; monitoring with medical equipment, consultations and current treatments; issuance of prenuptial certificates); - to fulfil the fiscal obligations related to the payment of the services provided to you; - to accomplish the obligations established by law on our company; - to meet our professional obligation to keep records of performed medical acts.

This data will be archived for a given period according to the law.

3. We do not use personal data for automated processing or for profile creation. We never make automatic decisions about you. We use technical means to store data securely. We do not process data for secondary purposes incompatible with the purposes for which we collected it.

4. We strictly observe and ensure professional secrecy. We disclose the data only to fulfil your interests or meet our legal obligations. Confidentiality is for us not only a professional obligation, but also an essential value.

5. We review the data collected each year, examining the extent to which its retention is necessary for the aforementioned purposes, your legitimate interests or the fulfilment of our legal obligations as a company. Data that is no longer needed will be deleted

6. You have **the right to access, intervene, rectify and port the data you provide to us, to limit the processing performed by us and even to request the deletion of data.** Please note that the intervention on the data you have provided to us may be likely to prevent the performance of the services requested by you. In this case the company is exempted from liability.
